



How is PHIP Funded?



Public Health Intervention Program (PHIP)

Insured

Medical/Lab Cost

- -Bill primary insurance
- -PHIP Covers PrEP copays/deductibles
- -Anywhere in-network w/plan

Medication

- -Gilead/Viiv copay assistance
- -PHIP pays for any remaining copay/deductible (oral only)

Uninsured

- Medical/Lab Cost
- -PHIP specific billing rates
- -PHIPcontracted agencies only

Medication

- -Gilead PAP
- -Ready, Set, PrEP
- -PHIP pays for any remaining copay/deductible

Medicare

Medical/Lab Cost

- -Bill primary insurance
- -PHIP Covers PrEP copays/deductibles

Medication

- -Medicare Part D Programs only
- -PHIP pays for copay

Underinsured

<u>Medication</u>

- -Gilead copay card
- -PHIP pays for any remaining copay/deductible

PHIP Eligibility Criteria

- Colorado resident
- Annual income under 500% FPL
- Meet medical criteria for PrEP

*No PHIP benefits for individuals with traditional Medicaid coverage


