

## Sens. Merkley, Smith, Colleagues Sound Alarm on Unlawful Charges for PrEP Patients

WASHINGTON, Sept. 9 -- Sen. Jeff Merkley, D-Oregon, issued the following news release and letter on Sept. 8, 2022:

Oregon's U.S. Senator Jeff Merkley and Tina Smith (D-MN) are joined by Senators Chris Van Hollen (D-MD), Elizabeth Warren (D-MA), Bernie Sanders (I-VT), Tammy Baldwin (D-WI), Edward J. Markey (D-MA), and Cory Booker (D-NJ) in a letter to AHIP, the trade association representing health insurance companies. The letter expresses concerns about the continued practice of unlawfully charging individuals for pre-exposure prophylaxis (PrEP) medication and related care.



#### **Private Insurance: Case Report from Massachusetts**

- ► MA resident on ACA Marketplace plan
- Charged \$15 copay every time he completed a telehealth or in office visit for > 1 year
- Called insurer several times from Feb-May 2022
  - -Told that PrEP was not a "preventive service"
- Despite health center help advocating with plan, no progress
- Stopped PrEP and tested positive in June 2022

#### AG Campbell Leads Multistate Coalition, Issues Consumer Advisory Supporting Access to HIV Prevention Drugs and Services at No Cost to Patients

**BOSTON** — Massachusetts Attorney General Andrea Joy Campbell has led a coalition of 22 attorneys general in submitting a letter to the Centers for Disease Control and Prevention (CDC) and National Center for Health Statistics (NCHS) advocating for a new diagnostic code for Preexposure Prophylaxis (PrEP) for HIV prevention in the International Classification of Diseases – Tenth Revision (ICD-10), which would reduce coding ambiguity and ensure that patients are not improperly charged copays for preventative services.

Today, AG Campbell also issued an <u>advisory</u> for Massachusetts consumers with information about the right to PrEP and associated services without any out-of-pocket costs in most instances.

#### Braidwood v Becerra

- ACA requires no-copay preventive services
  - PrEP given A-rating by USPSTF in 2019
- Plaintiffs challenge
  - constitutionality of mandate based on USPSTF recommendations
  - coverage of PrEP by employers objecting on religious grounds
- ► HIV+Hep & 24 organizations submitted *amicus* brief focused on HIV
- ▶ District Court ruled in favor of plaintiffs on most issues but decision is stayed on appeal to Fifth Circuit
- ACA preventive services mandate remains the law of the land
  - ► Fifth Circuit expected to rule later this year
  - any decision likely to be appealed to Supreme Court



#### **National-level advocacy**

- NASTAD billing & coding guide
- ► White House convening on PrEP copays
  - ► CCIIO enforcement
  - ▶ DOL for ERISA plans
  - CDC involved
- Defend ACA protections
  - Preventive services, harmful benefit designs
- ► PrEP Access & Coverage Act HR 4392/S 2188



#### State-level advocacy

- Formal insurance complaints
  - insurance dept or AG office
- Press coverage
- Advocate for state legislation
  - ▶ \$0 copay
  - no prior auth
  - pharmacy-based PrEP
  - preventive service coverage
  - CA, CO, IL, NJ, NY, ME, NV, RI
- ► Advocate for state PrEP insurance guidance
  - ► AL, CA, CO, GA, IL, MA, MI, NM, NY



#### Medicare

- Medicare coverage of PrEP
  - Out-of-pocket costs can be high
  - Some plans cover LA PrEP (mix of Part B and Part D)
- National Coverage Determination (NCD)
  - ViiV requested NCD for provider-administered PrEP
  - ► HIV+Hep & 64 orgs request timely NCD for LA PrEP
- CMS proposes to require no-copay coverage of both oral & injectable forms of PrEP (incl future drugs) in Part B



#### Medicare

- ► HIV+Hep & other orgs point out that billing Part B for oral meds poses challenges that could adversely affect access
  - Many PrEP users would need to switch pharmacies
  - Call on CMS to consult with patients, pharmacies, providers, plans before moving forward
  - Can oral PrEP be covered in both B & D?
  - No-copay coverage may not be possible in Part D
- CMS misses October 2023 deadline to finalize NCD Medicare coverage of PrEP
- Still waiting for CMS decision



#### Medicaid

- Critical to cover all forms of PrEP without prior authorization
- ▶ \$0 copay even low Medicaid copays are a barrier
- Network issues
- Reduce Medicaid churn issues
  - Many people churn between Medicaid, uninsurance, and private insurance
  - PrEP insurance navigation helps
